As you might have guessed, Paul Ysteboe was also our biggest Side Game Winner with 3 Gross Skins. He just edged out Ed Bailey's laser-like Par 3 shooting and his 3 KP's. Overall, 16 of our 31 golfers won either Scrip or Side-Game money.

One note - in the Team 'Game of the Day Event' we paid out the top 4 teams (25% of the field), including a 'Blind Draw' partnered team because one of our players had to cancel and we had no 'fill in' A player takers. Four teams also tied for 4th Place, and we went to a tie-breaker to determine that position.
