Results: Thursday 09-03-2020 2-Man Scramble & AGA Qualifier (Day 1)

37 golfers yesterday for one of two days of our annual 2-Man Team Scramble AGA qualifier. 19 teams for our Scramble 'Game of the Day', with 10 of those teams also participating in the AGA Qualifier. Painted Mountain FINALLY mowed most of the heavy rough just off the fairways, and around the greens to accommodate our request for better playing conditions this week because of the tournament. Another 8 teams are competing tomorrow.

The big news of the day was 87 year old **Don Worden's fourth lifetime hole-in-one**, on Hole #15! Don empties a very large \$400+ pot (+ \$100 more kicked in by the club)! A new pot will be starting tomorrow morning. The Scramble Format help the golfers hit an amazing 51 Birdies and 2 Eagles (one eagle was Don's hole-in-one)! 17 of our 18 holes were at least birdied, but only 4 of those birdies held up for gross skins.

The team of Stephen Ruth & Terry Stephens easily won our 'Game of the Day' with a SMOKIN' HOT Gross 63, Net 57.70 ... and every one of their 7 birdies were halved! The team of Dave Fjosee & Paul Ysteboe also shot a Gross 63 (5 birdies & 1 eagle), but it was only good enough for 4th place Net in our Game of the Day.

The Ed Bailey/Dave Kuenzi Team was our top Side Game winner with 1 Gross Skin, 2 Net Skins & 1 KP/Proxie, edging out Sam Miller/Don Worden and Bob Albright/Jim Seamandel who both had 1 Gross Skin, 1 Net Skin & 1 KP/Proxie. Overall, 24 of our 37 golfers (12 of 19 teams) won either Scrip or Side-Game money.
