25 golfers yesterday on a hot one at Painted Mountain. The slight but steady breeze helped a lot! Most finished in 3 hours & 30 to 45 minutes, but one group took more than 4 1/2 hours to finish. Just a reminder to do everything in your power to be at 2 hours after 9 holes to ensure you'll finish in 4 hours or less – ESPECIALLY in the Summer when temperatures are soaring. If you can't see the group ahead of you, play fast! 20% of the field shot in the 70's (5 golfers), but just 3 in the Net 60's. 14 Birdies and Tom Guinan's Eagle on Hole #3, on 8 holes, with 5 holding up for Gross Skins.

Bobby James led the A-Flight with a 74, a few better than Michael Waldroup's 76 (*his best PM round ever*). Eli Latina's 77 was a shot behind that. Michael's Net 64 was Flight low, two better than Eli's Net 66. Larry Smith's 84 led the B-Flight, two better than Steve Ruth's 86. Reinhard Zimmermann's Net 71 was B-Flight low, edging out Larry, Steve & Sam Miller. ***See the results below for a more detailed listing of our Game of the Day (GOTD) Scrip winners.***
