Results: THURSDAY JULY 21ST 2-PERSON A/B BEST BALL NET

24 golfers this morning in league on hot, somewhat humid and blustery day. On 'gross score' appearances, it was a tougher scoring day with just 9 Birdies on 8 holes ... but resulted in 7 Gross Skins, and more than half the field shot within a few strokes of Net Par (Net 70)! There were, however, just three golfers breaking 80, and five shooting in the Net 60's.

Brad Fawcett's very nice personal Painted Mountain best 74 led all golfers, with Pat Goth & new member Leonard Kuhnlein three strokes back at 77. Larry Stone was next at 81. Brad's Net 66 was also low for the day, two strokes better than Ed Bailey's & Ken Sturm's Net 68's and three better than Larry Stone's & Dennis Paperman's Net 69's. Four others were at Net Par (Net 70) – Carrol Brown, Margaret Stephens, Jim Chavez & Lynda Leaper.

On the 2-Person 'Game of the Day' Event, Brad Fawcett & Dennis Paperman led all teams with Net 61's, three strokes better than the Net 64's shot by the teams of Larry Stone & Diane Mason and Ken Sturm & Margaret Stephens. *See the detailed results below for more details of what each golfer did.*

Playing his first round at Painted Mountain, Leonard Kuhnlein had some excellent holes and they propelled him to be our top Side-Game Cash winner with 2 Gross Skins & 3 KP/Proxies. Lynda Leaper & Wayne Miller also had very solid days with 1 Gross Skin, 1 Net Skin & 1 KP/Proxie each for second place. Overall, 15 of our 24 golfers in the game (54%) won Pro Shop Scrip or Side-Game cash.
